Rules O Say, Can You See

This exhibition is open to all 2-D & 3-D artists.

All Artwork submitted must be original.

All Artwork must not have appeared in a previous show at the Louisa Arts Center.

All 2-D (to include drawing, painting, collage, photography, low relief, etc.) artwork must be framed in a professional manner and ready to hang from picture molding (hanging rings, brackets, wire, etc. on both sides on back of the work). NO saw tooth hangers please.

All artwork must be clearly identified on the back with Artist Name, Title, Medium Sale Price or NFS/Value

Artwork is not required to be for sale, but if for sale and is sold, the Center will retain a 30% commission. The artist shall contact the Arts Center and remit 15% of the sale price of any item which is purchased by an Arts Center client or referral from opening night to 365 days later.

Artwork will remain on display until the end of the show.

The Louisa Arts Center takes every precaution to protect entries from damage and loss; however the artwork is NOT insured by the Center.

The Center reserves the right to reject from exhibition artworks accepted by juror, due to content or inability to properly install the work.

By submitting artwork for entry, the artist agrees to allow work to be shown and reproduced for publicity purposes

Artwork must be picked up on the date indicated in the calendar on the reverse side of this application. Artwork left at the Center for more than 60 days after the close of this show will become the property of the Center.

Artwork must be submitted between 9a.m.-11a.m. the Saturday prior to the show opening, and be accompanied by a completed entry form.

Artwork not accepted must be picked up during Gallery hours prior to the show opening. Artists will be notified by Tuesday regarding art work selection. Artists will be notified by email and are responsible for checking their email account.
